As noted by Liff and Shepherd (2004), netiquette emerged as a means of managing the complexities of digital communication and resolving conflicts that arose from misunderstandings or breaches of online decorum. While early internet spaces were largely unregulated, the evolution of online communities has led to the establishment of various norms and standards for behavior, some of which are more formalized in platforms like LinkedIn or academia-related forums, and others more relaxed in spaces like Twitter or Reddit (Deris et al., 2015).
